Dr. César A. Cruz

From marching 76-straight miles, to hunger striking for 26 days, César has dedicated his life to fighting for justice.

He has been an educator for 23 years, in positions of leadership for the last 17 years, most recently serving as the Dean of Secondary Schools Program at Harvard University. He cofounded the independent school, Making Changes, out of his home and has sought to create autonomous education spaces. He received his doctorate in Educational Leadership at the Harvard Graduate School of Education, becoming the first Mexican immigrant male to do SO.

Terisa is an award-winning poet, teaching artist, mental health educator, and community leader born and rooted in the Bay Area.

Her presence in the poetry world as a queer Samoan woman and activist has granted her opportunities to perform and speak in places ranging from the White House (during the Obama administration) to the UN Conference on Climate Change in Paris, France. The most memorable moment in her career was receiving President Obama's Champion of Change Award in 2012 for her activism as a spoken word poet/organizer in her Pacific Islander community.

Terisa's writing blends the personal, cultural, and political in a way that calls for healing, courage, justice, and truth.

What's RIGHT with this Picture?

San Bernardino Valley Colleges' Strategy for Success!"



Impacting student's lives through education provides a ripple effect that positively impacts the lives of their families, their quality of life, and the quality of place in the communities where they live and work.

San Bernardino Valley College is implementing just such a ripple effect which started with a Guided Pathways initiative championed by the faculty and President Diana Z. Rodriguez in May 2019. All classified staff, faculty, and administrators were invited to engage in the conversation. These stakeholders were a part of the dialog from the onset, and as a result, the program is moving forward smoothly because everyone understands the basis of the SBVC Guided Pathways strategies and had input into the results they hoped to see.

"Throughout the year, our team has created the foundation needed to take SBVC and our students into the next decade," said President Rodriguez. "The paradigm shift focused on Guided Pathways being embraced by our campus community and we are implementing strategies throughout campus developed from our dialogue on how to improve student completion and success rates."

Current SBVC students were also invited to join the conversation which

provided unique insight - especially with initiatives like AB 705. "Some students were excited, and some were a little intimidated by the lack of remediation courses. Some haven't done a quadratic equation in a long time, but this gave us an opportunity to come alongside the student and reassure their understanding of the process," added Rodriguez.

"The foundation of "what's right with our strategy" is we started with a common goal, returned to the heart of our mission, and are maintaining a laser focus on achieving our goals," added Rodriguez. "These core values can be summed up in two words- student success. Success in life, achieving student goals, providing for their families now and in the future, and success in implementing positive change in the communities we serve."

SBVC plans to stay the course for their remaining Guided Pathways 'paradigm shift' objectives into the year 2020, while also maintaining a mindset of continuous improvement for current strategies. "While progress is being made," Rodriguez said. "We don't just have Guided Pathways meetings- it's a call-toaction team that comes together on a regular basis and we will always look for ways to improve our strategies for our students."
