Jerry Nickelsburg, Faculty Director and Adjunct Professor of Economics, Anderson School of Management, UCLA

Since 2017, Jerry Nickelsburg has served as faculty director of UCLA's formidable economic forecast and he plays a key role in the economic modeling and forecasting of the national, California and regional economic trends, particularly in the manufacturing, trade, and labor markets.

In addition, Nickelsburg teaches economics in UCLA Anderson's MBA program, with a focus on business forecasting and international business economics. He travels regularly with students to Asia as professor and advisor in global immersion courses.

Nickelsburg is frequently cited in the national media. He has published more than 100 scholarly and popular articles on economic policy, monetary economics, statistics, labor economics and industrial organization. He is the author of two books on monetary economics and exchange rates.
